Hi Lee,

Liam Walsh and I are planning on writing a story about how Jon Grayson dealt with policy areas surrounding coal seam gas and water, while he held a stake in a private business working in that sector.

We have obtained documents via Right to Information laws. One is a briefing paper from April 2013 signed by Jon Grayson. In it, he discusses federal policy affecting oversight of CSG projects with water bodies. The briefing note describes the federal policy as having ramifications such as project delays.

At this same time, Mr Grayson, via Queensland Office Nominees (No 1), was one of two shareholders in Gasfields Water Management (the other being Australian Water Holdings).

We are writing a story about this conflict of interest. Mr Grayson is noted in ICAC documents as having met with his predecessor, John Bradley, about CSG and water. And Australian Water said it was imperative to have a positive relationship with the Department of Premier and Cabinet.

Now these RTI documents show Mr Grayson was also giving advice and advocating policy (as in the Federal changes would be detrimental) about CSG and water. He even, in a handwritten note, advocated sending a letter to the Prime Minister about the changes. He also dealt with the COAG reform touching on CSG.

- 1. Did Mr Grayson recognise he had a potential/real conflict of interest in this case?
- 2. If he did, how did he manage it? (We note that even the public service handbook suggests resolution strategies be put in place)
- 3. If he did not recognise a potential/real conflict of interest, why didn't he?
- 4. Why did Mr Grayson feel it was acceptable, even with his private business connection, to be giving advice/policy briefings about CSG-water?
- 5. We only got an RTI on briefing notes on how many other occasions has Mr Grayson, as DG, given advice or discussed CSG-water issues?
- 6. Please provide examples of any time he has, due to a declared conflict of interest, not been involved in water-CSG issues.
- 7. Could you please clarify the date the letter from the Premier to Tony Burke was mailed and was this the separate letter referred to in Mr Grayson's handwritten note?
- 8. We also did an RTI to see how Jon Grayson was recruited as DG. It turned up no documents. Could you explain why? Does this mean that Mr Grayson was selected before the Newman Government came into power?
- 9. Did the Premier or anyone involved in selecting Mr Grayson have any contact with or get references from people from Australian Water Holdings? This would include Santo Santoro (a former board member of AWH's Queensland arm).
