Dear Mr Madrers and Mr Brinsmead

Thank you for your letter of 6 October 2010 concerning the Pearls Group's commitment to Australia. I have been requested to reply to you on the Premier's behalf.

The Premier was pleased to meet with you in Dethi regarding the Pearls Group's investment plans in Queensland. The Premier sincerely hopes that these plans come to fruition.

With regards to Mr Nirmal Singh Bhangoo's interest in applying for an Australian business visa, I am advised that he should be made aware that all migration decisions are the responsibility of the Australian Government, through the Department of Immigration and Citizenship (DIAC).

Obtaining a business visa can be done through a number of visa categories, including a Business Talent Visa (Subclass 132). This visa provides successful applicants with permanent residency. Other business migration visas of a provisional type, and valid for four years, are also possible. Permanent residency is then available for people who have successfully commenced a business operation. Details of the Australian Government's business migration options can be found in a booklet published by DIAC, which is available online at www.immi.gov.au/allforms/booklets/books7.htm.

I am advised that the Queensland Government does, however, have a role in assisting suitable applicants wishing to live in and establish a business in Queensland, through several state sponsored business visas. Queensland sponsorship for sponsored business visas may be obtained through the Queensland Government's Skilled and Business Migration Unit. Queensland's business migration sponsorship requirements and contact details are available online at www.workliveplay.qld.gov.au.

It should be noted that a sponsored business visa would apply only to the applicant (Mr Bhangoo), his spouse and his dependent children. Any other family members wishing to migrate to Australia would need to be eligible for, and apply for other appropriate visas. Mr Reinders can also make appropriate referrals for extended family members who may wish to consider other forms of visas.

I trust the information above is of assistance, and the Premier looks forward to hearing about your future Queensland business and investment activities.
