New services to help keep domestic violence victims safe

Victims of domestic and family violence in Far North Queensland will soon have access to greater support with an extra \$3.7 million in funding over five years amounced for local services.

Minister for the Prevention of Domestic and Family Violence Shannon Fentiman said the funding boost included extra funds for Cairns and the Tablelands and a new service for the Cassowary Coast, where there is no dedicated domestic violence support service.

"Domestic violence is having a devastating impact on our Queensland community and the Far North has some of the highest rates in the state," Ms Fentimen said.

"More and more people are taking the brave step of speaking out and seeking help and we've got to have the services there to support them.

"This funding will help provide better access to specialist counselling, information and support which can make all the difference to people affected by domestic and family violence.

Member for Cairns Rob Pyne welcomed the increase in funding for the Cairns Regional Domestic Violence Service for its Cairns-based service and further support for the Tablelands.

"Domestic and family violence is something we need to be standing up against as a community and I believe the people of Cairns are committed to doing that," Mr Pyne said.

"I know what a fantastic job the dedicated team do to help victims of domestic violence here in Cairns and this boost will help cater for increasing demand for their much-needed services."

The Far North Queensland funding package includes:

- Cairns Regional Domestic Violence Service will receive an extra \$1.53 million over five years to provide new services for the Tablelands, beginning in March.
- Cairns Regional Domestic Violence Service will also receive an extra \$209,000 until mid-2018
 for domestic and family violence counselling services, including more than \$28,000 to provide
 safety upgrades. This builds on a recent \$88,000 provided in one-off funds to help the service
 meet increased demand.

• Tully Support Centre will receive \$1.82 million over five years for new services including counselling for adults and children on the Cassowary Coast and court based support at the Innisfail and Tully Magistrates Courts.

Further funds targeting support for Cape York will be available in the next round of funding for services to start in August 2016.

The funding is part of an overall \$49 million commitment over five years to increase local services working to tackle domestic and family violence and delivers on a number of recommendations in the *Not Now, Not Ever* report

Thanks again for spending some time with Russ Morgan at our first Last Friday Forum yesterday.

As you could tell, Russ is a person of great integrity, experience and enthusiasm. Working with him is one of the highlights of my life.

For me, some of the key messages from our conversation with Russ were.

- our work is very important and carries great responsibility our role is to help tell the people of Queensland what the Government of Queensland is doing on their behalf (most often with their money)
- localised stories (not matter how small) are the difference in the regions and the suburbs so take the time to localise a centralised announcement
- there is no more important stakeholder than the local MPs and giving them material to get the message out locally
- we are professionals and we need to respect the professionalism of those in the media we work with (he said there were some exceptions to this during the Goss Government and he presumed there would be some exceptions today) but there should never be exceptions in how we work with the media. If we are courteous and responsive, the journalist is more likely to call us to guide them through a pile of information the Opposition and others might have given them it is about forging a relationship beyond the next edition or radio/TV bulletin.

The other thing it reminded me of – and it's a good reminder for all of us – there's a lot of Queenslanders who want/need us to do well.

Thanks so much to Scott Forbes (Treasurer) for bringing this together, including the press conference with the Treasurer and our local MPs Rob Pyne and Craig Crawford to make the announcement at the site for the Cairns Special School.

Think about the Cairn's Special School – the LNP promised it in 2012 only because Labor had already pledged to build it. The LNP didn't fund or build it. The Palaszczuk Labor Government is; and we are accelerating the build and the 70 FTE jobs that goes with it. Cairns will no longer will be a major provincial city without a dedicated Special School thanks to the Government we are all working in.

The story wasn't possible without Matt Jutsum (Education), Tim Shipstone (Energy and Roads) and Peter Clarke (Public Works) and their offices.

BTW I sent the front page to Russ (who is a northerner) this morning. His response: "rolled gold".

This week, I prepared a media statement for our hard-working Member for Mackay Julieanne Gilbert on the Accelerated Works Program in her region.

The announcement was correct, but I had not asked Minister Bailey's office to check it. One of the items in the release referred to works at Abbot Point, and while it was not related to the Adami Carmichael Coal project, the lack of detail in the release I prepared led some stakeholders to misinterpret the Government's action.

This created a lot of traffic and push back, particularly for Minister Bailey's office. The Minister had to take time out of his schedule to remedy the situation with a video message and clean up media reports based on stakeholder group's comments. It was my mistake not to liaise with Minister Bailey's office prior to the release and created a distraction for a lot of people.

It's was a lesson for me – the Minister's office is the domain expert and we need to consider the stakeholder/industry association reaction.

I let down the team. Please accept my apologies.

If you're in Gladstone tomorrow, I will see you there. If not, I hope you have a good weekend. As discussed, will schedule our weekly Ministerial Media Advisers Meeting for next Friday – keen to discuss preparations for Parliament.

BACKGROUND:

On 1 November 2015, Mr Bob Johnson, Chairman of the QLGRA, wrote to you and the Honourable Annastacia Palaszczuk MP, Premier and Minister for the Arts, indicating the QLGRA's support for Mr Rob Pyne MP, Member for Cairns, and his recent proposal that the Government implement a State-wide inquiry into the conduct of local governments in Queensland (Attachment 2). In addition, the QLGRA requested a meeting with you to discuss this matter, and the Government's policy position in relation to significant local government boundary reviews.

In response to this request, Mr Peter Clarke, Senior Advisor in your office, agreed to meet with QLGRA representatives on your behalf.

On 19 November 2015, Mr Clarke and Mr Max Barrie, Director Program Implementation and Review, Local Government and Regional Services in the Department of Infrastructure, Local Government and Planning (the Department), met with the following QLGRA representatives:

- Mr Bob Johnson, Chairman QLGRA and Chairman Save Our Shires Action Group Stanthorpe Inc
- Colonel Ken Park (retired), Strategies Officer QLGRA and Chairman Reclaim Caboolture Shire
- Mr Joseph Monsour, Secretary QLGRA and Secretary Boonah Local Government Reform Group
- Mr Cliff Thomas, Vice Chair QLGRA (Maryborough)
- Mr Tony Richmond, Vice President, Capella Peak Downs Shire De-amalgamation Committee.

By way of further background, officers of the Department previously met with representatives of the QLGRA on 26 August 2015 to discuss the Government's policy in relation to local government de-amalgamation proposals and significant local government boundary changes.

KEY ISSUES:

Out the outset it was confirmed with the QLGRA that the Government's current policy position in relation to proposals for de-amalgamations and significant local government boundary changes remains unchanged. This policy requires the following criteria to be met before a referral to the Local Government Change Commission (Change Commission) is considered:

In addition, the Government would only implement a recommendation of the Change Commission after a successful referendum of all residents affected by the proposed change. The QLGRA representatives were also advised that the Government has no plans to undertake a review of the effectiveness of local government amalgamations in 2008.

Notwithstanding this, the QLGRA were invited to put forward any additional suggestions for your consideration.

The QLGRA cited the recent representations by Mr Pyne on behalf of various groups and individuals who have called for a wide-ranging review of the local government system. While no specific instances in relation to the maladministration of a local government or individual councillor conduct were raised by the QLGRA, clarification was provided in relation to the role of various authorities involved in investigating and dealing with local government related complaints. Discussions included the role of the Minister for Local Government and the differing roles of the Department, the Crime and Corruption Commission and the Queensland Police Service in conducting investigations into councillor misconduct and corrupt conduct complaints.

Of primary concern to the QLGRA, however, is the Government's policy in relation to significant local government boundary changes. In addition to issues raised previously by the QLGRA at its meeting with Departmental representatives on 26 August 2015 (Attachment 3), the QLGRA reiterated its concerns that the current policy is too rigid. It also re-stated that the requirement for local governments to agree to significant boundary changes is difficult to achieve and that councils often have a conflict of interest in considering such proposals.

In support of this argument, the QLGRA raised the decision made by the Central Highlands Regional Council in response to a petition seeking support for the de-amalgamation of the former Peak Downs Shire. On 9 September 2015, the Central Highlands Regional Council resolved not to support this proposal. As the vote was split, the Mayor used his casting vote to oppose the proposal, effectively stifling the petitioners' wishes for a proper review to be conducted on this issue.

Ultimately, the QLGRA would like to see the Government reconsider its policy position, suggesting that an independent review is the only fair and equitable option. In addition, the QLGRA voiced its views that any costs associated with a potential de-amalgamation or realignment scenario should be borne by the State Government, and not the affected local governments or their communities.

The QLGRA argues that rates and charges in some local government areas have doubled since the 2008 local government amalgamations, and that the realignment or reduction in the size of some local government areas would provide for more sustainable communities into the future.

In lieu of its initial request for a State-wide review of local government boundaries across Queensland, the QLGRA suggested that the State implement a pilot review of two amalgamated local government areas in a bid to progress this issue further.

Having regard to the Government's policy, the Department does not recommend the State consider the QLGRA's proposal for the State to conduct a pilot review unless it is consistent with the policy. At this time, the QLGRA has not demonstrated that the three requirements of the policy have been met.

As a follow-up to this meeting, it is proposed the attached letter be signed by the Chief of Staff, on your behalf, thanking the QLGRA for bringing these issues to your attention.

Thank you for your emails about issues raised with you by members of the public in respect to their concerns with their local governments.

The Department of Infrastructure, Local Government and Planning (the Department) has reviewed the emails you provided as the basis for your call for an inquiry into the local government system in Queensland. The Department is of the opinion the issues amount to localised matters specific to each of the local governments in question and do not provide cogent evidence of systemic problems with the local government system that would justify an inquiry into local government.

Exempt Sch.3(12)(1) Prohibited by Act

As you are aware, local governments in Queensland are autonomous, with a range of responsibilities and mechanisms to appropriately deal with matters including planning, compliance and complaint management and resolution.

The appropriate method by which affected parties should seek remedies to their individual circumstances is to first address their particular matter with the relevant local government. In some of the cases raised, I understand affected parties have also availed themselves of appear and complaints process rights with relevant agencies which is entirely appropriate.

In the circumstances, I do not intend to take any further action in relation to these matters. I would recommend you encourage people with issues with their local governments to raise them formally through the appropriate complaints or appeals process.
